- Fulfilling our share of the responsibility to keep the global temperature rise below 1.5° Celsius, continuing to reduce our impact on air, land, and water.

We project that carbon emissions will decrease over the next five years to 22 tCO2e by 2027. This is a reduction of 50%.

# **Carbon Reduction Projects**

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline.

LLS UK has signed up to the SME Climate Hub

Accreditation to ISO 14001 was achieved in August 2023.

Moving office location from Canary Wharf (150 desks) to Monument (33 desks) to reduce the size of the footprint needed and work towards the goal of 100% renewable energy.

- Along with moving office LLS moved to a hybrid working model, significantly reducing the CO2 footprint of our service provision
- This has also led to reducing its reliance on printers and is working towards becoming a paperless office
- Removal of office vending machine to reduce plastic waste
